9A. Review of Current Contract for the Operation of the Equestrian Center and Vote on Direction to Staff

At the May 27, 2021 Board of Directors meeting, Doug Lofstrom presented the Equestrian Center Study as part of the Leadership Committee's report.

Chair Rubalcava-Garcia indicated that the study would be included in the Board's upcoming strategic planning process, but asked that the Board review the current rental agreement for operation of the Equestrian Center and vote on direction to staff for moving forward. The current rental agreement contains a carry-over clause which allows for continuation on a month-to-month basis.

The Board will review and discuss the agreement to provide staff direction.

9B. Review of and Vote on Whether or Not to Approve Amendment to Spectra Master Concessionaire Agreement Clarifying the “Cantina” as Part of District’s Facilities

The Cantina facility in the former OC Market Place footprint was operated by Spectra as part of the swap meet operation. An amendment to the Spectra food service management agreement is necessary to clarify that the Cantina now becomes part of the “District’s Facilities” as defined in the agreement, and may be operated by Spectra for the sale of food and beverage items during the annual OC Fair and other events.

The amendment further clarifies that Spectra shall pay the District a commission on gross sales generated by Spectra at the Cantina at the rates described in Section 1 of the agreement and in accordance with the terms of Section 1.

RECOMMENDATION:

Approve the amendment to the Spectra master concessionaire agreement.



9C. Vote on Whether or Not to Use the August Board Meeting Date and Time for Strategic Planning

The Board of Directors will be participating in a strategic planning process following the close of the 2021 OC Fair. A suggestion was made to forego a regular August Board meeting and use the scheduled date/time of August 26, 2021 at 9:00 a.m. to focus on strategic planning.

9D. Presentation of Proposed Changes to Heroes Hall Veterans Foundation MOU and Vote on Whether or Not to Approve

The MOU between the 32nd District Agricultural Association and the Heroes Hall Veterans Foundation includes an agreement of a minimum \$45,000 contribution to the District for operational expenses of Heroes Hall.

The Foundation would like to amend the MOU to reflect a lower contribution amount for the next three years.

The Board will discuss and vote on whether or not to approve the requested change.

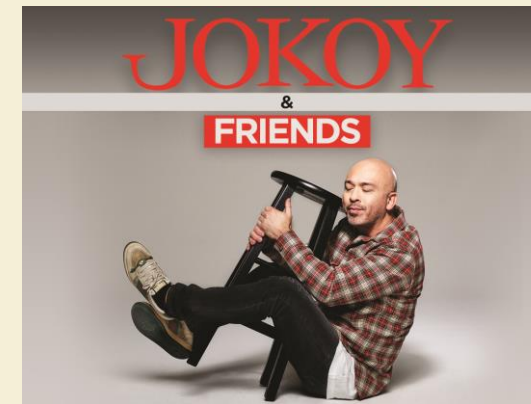

LGBTQ Pride Month

Introduction

What is Pride Month?

- LGBTQ Pride Month commemorates the Stonewall riots, which occurred at the end of June 1969
- Pride stands for “Promote Respect, Inclusion, and Dignity for Everyone”

Why do we celebrate Pride Month at OCFEC?

- An estimated 4.5% of Americans identify as members of the LGBTQ community – part of the community we serve at OC Fair & Event Center
- The Pride Flag is displayed year-round at OCFEC as a symbol of welcoming to all





Interesting facts

- The LGBTQ rights movement in the US was kickstarted in 1969 with the Stonewall Inn riots
- The rainbow flag was designed in 1978 by Gilbert Baker
- The first OC Pride Parade was held in 1989
- President Obama announced the designation of the first national monument to LGBTQ rights in 2016
- May 23, 2019: OC Fair & Event Center Board of Directors approves a resolution and policy recognizing June as National LGBTQ Pride Month and direction for OC FEC to fly the rainbow flag year-round
