SUMMARY OF COMMITTEE MEETING

The committee met on June 17, 2022 and discussed the following:

Review of the May Financials:

- District operations continue to perform favorably to the 2022 budget.
- YTD May 2022 revenue is \$3.6M and is favorable to budget by \$778K. Revenue for the month of May was ahead of budget by over \$111K, mainly due to additional events held during the month which were not included in the budget. However, parking revenue for the scheduled events was slightly lower than budgeted.
- Operating expenses for YTD May 2022 are \$8.33M and are favorable to budget by \$1.78M.

- For the YTD period ending May 31, 2022, net proceeds are \$2.78M favorable to budget.
- For the period ending May 31, 2022, cash and investments are \$62.9M.

2021 Financial Audit:

- The audit is nearing completion and draft reports should be available from the auditors next week.

Follow-up

- The next meeting of the Financial Monitoring and Audit Committee is scheduled for a date to be determined in July.
