I understand that you are on the Board of the OC Fairgrounds including the Equestrian Center ("EQC"). I'm reaching out for your assistance. My daughter, Alex Creelman, is a long time resident of Orange County (Costa Mesa and Newport Beach) since her college graduation in 2007, and she grew up in La Mesa where she attended Grossmont High School and learned to ride horses at the stables in the adjacent Spring Valley area. Learning to ride and care for horses was her passionate avocation and I felt that experience helped her to become the successful businesswoman and mom as she is today. Alex enjoyed riding at the EQC, and now she takes my 5 year old granddaughter, LuLu, who also really loves learning to ride and care for horses.

I've also had the opportunity in the past to visit the EQC with my daughter and I was very impressed that such a great facility existed in a relatively dense urban environment and is definitely preserving for generations to come.

Alex advised me that OC Fairgrounds may be seeking to re-purpose the space and I have since read some local media on the subject. Of course, Alex and her friends in OC were devastated to learn that they might lose this important recreational facility and would like to both encourage the Board not to let that happen and also offer their advocacy and assistance to the Board to keep that from happening. I'm hoping you can help by advocating to keep the EQC open. I'd love to speak with you if possible and/or connect you with my daughter.

I'm also reaching out to you because I noticed while doing some research that you and I share the City of La Mesa in common. Although I'm not sure our paths crossed then, I became involved with the City as the elected President of the La Mesa Youth Sports Council with nearly 5,000 registered participants, President of La Mesa National Little League, and Chairman of the Bond Oversight Committee for La Mesa/Spring Valley School District. In 1999 I assisted in forming the La Mesa Park and Recreation Foundation and became its first Vice President serving under President Ed Burr ("Edco"). Our Foundation was instrumental in connecting the fields at Parkway Middle School for joint use and - eventually - with the assistance of Junior Seau - built the Junior Seau youth football field and the adjacent grass space for 3 baseball/softball diamonds plus space for 3 youth soccer fields. I'm a huge fan of developing and maintaining space and activities that promote the health and welfare of members of our community. I hope the EQC is maintained not only for the benefit of my daughter and granddaughter but also for generations who come after.

In my life experience of 70 years, I believe the EQC is a very unique and wonderful place, and I hope it continues well into the future.

I am trying to rearrange my schedule to be able to make this meeting, but I wanted to email, just in case I cannot.

The equestrian center at the OC Fairgrounds is a huge public benefit. There are so few places left in Orange County, especially in the super urban parts of the county, that have horses. After the loss of Rancho Del Rio in Anaheim, it is the only public horse facility in central county. The equestrian center offers kids and adults the ability to be around animals that they may never get to see. Multiple trainers offer riding programs for 'horse crazy' kids and adults, which is absolutely amazing! OC Vaulting offers the only vaulting program in Orange County and teaches so much more than just 'dancing with horses'.

The fun-days that have been able to happen since post pandemic have been so much fun! The most recent halloween costume parade and exhibition was a blast. It was so much fun to see the community gather at the Equestrian center to see how much fun we have with our hooved family!

My daughter is a former member the OC Vaulting team, and I am a current volunteer. We learned about OC Vaulting at Imaginology and signed up for their recreational class. (Which is the only one in Orange County.) She fell in love with it. The mix of gymnastics and horses made her happy. (If you have met many 16 year olds, you'll know that not much does that these days....) She worked hard and advanced to the competition team. When I say that these kids pour their hearts and souls into these horses, I'm not exaggerating. They come early to set up feed for their horses and groom and tack them up for classes. Many of these kids are at the center 3 or 4 days a week to care for the horses.

And then there are the adults. My daughter has since moved on from vaulting, but I stayed. We have other adults that either had kids in the program or that just wanted to be around horses. They learn to lunge for classes and competitions and they keep the vaulting horses fit and happy between classes. As an adult volunteer, I get as much out of these animals as the kids do, if not more.

I grew up here in Orange County. I love it here. I love that we have this option of having horse-life in the middle of our cities. There is so much more that could be done to make this center even better, if you would just give it a chance.

Dear Board Member:

I have spoken at many meetings, written a number of letters to you over the past few years and heard many people speak to the Board about the benefits of horses to them or their children. I am once again astonished that the question of the public benefit of the Equestrian Center at the Fairgrounds (EQC) is even up for discussion.

There are fewer and fewer places in Orange County which can accommodate the need for space for horses. Equestrians are athletes, recognized as Olympic sports in various equestrian disciplines, and require space as do other sports such as football, baseball, soccer and other sports which are commonly made available to the public. It so happens that equestrian sports tend to be predominated by female athletes at the early levels, which includes beginner level and up through various competitive levels, who participate at the EQC.

The mission of the 32nd DAA is: "Creating equitable community access to agriculture, entertainment, cultural and educational experiences". The EQC provides such access through the ability of the public to board horses, and for the public to take lessons from trainers who provide lessons on the horses that the trainers or others own. Here is the plaque honoring the Board members who had the vision to create the Equestrian Center when the existing site was first opened in 1979.

The connection to horses is indeed magical and therapeutic to many who have made that connection. Some choose to become dedicated equestrians, others enjoy it for a time and move to other passions. All benefit from learning to ride, from the feeling of controlling an animal many times the size of the person, and from experiencing the movement of the horse, which itself has therapeutic benefits for many, both mentally, emotionally and physically. The benefits to individuals increase as a child or an adult becomes immersed in becoming an equestrian. The immersive experience reaches deep into the soul of a person; it is far more than a brief encounter with a horse that one has by just observing or touching a horse.

Since the Covid pandemic, there has been an increase in the number of people wanting to take lessons, to connect with horses, to find ways to get their children outdoors and experience the joy of horses. The many lesson and camp programs available at the EQC have been invaluable to these families. The impact of each encounter may be far greater than you imagine.

As a little girl, I watched horses being ridden from the stables down my street, and I went to see them every day. I begged my parents for a horse, and finally got one when I was 11 years old. That horse kept me out of trouble in high school, and motivated me to pursue a career where I could afford a horse. After a 20 year break in riding, I started

riding again by taking lessons here at the EQC over 11 years ago. My own fitness level has improved, while I have also enjoyed watching children learn to ride and become confident young adults.

Since the Fairgrounds have taken over management of the EQC, management has made choices to:

- Engage in a contract resulting in a loss of approximately \$100K per month, with Board approval at the outset despite the objection of equestrians before the contract was entered into;
- Reduced public access by providing signage which discourages public participation;
- Reduced public access by its lack of promotion and by its emphasis on “private boarders and training”, while not acknowledging the public’s ability to obtain lessons from multiple trainers at the EQC; and
- Discouraged people who called to enquire about boarding, as reported to the Board in previous meetings.

Furthermore, the Fairgrounds management has not fulfilled its commitments to public programming (other than boarding) as set forth in its strategic plan. In fact, there has been no other discernible public programming offered by the OC FEC staff during its management of the EQC in 2023. The trainers and boarders have offered public programming in the form of lessons, docent tours, horse shows, Halloween parade, our Changing Strides programs including lessons for foster youth and other disadvantaged youth, and many other programs, and continue to kindly welcome visitors to the EQC.

As equestrians, we wish to continue to support public access and welcome opportunities to support the community in ways that are safe for the community and our horses.

Please seek an operator who can provide the level of service to the Orange County community which supports the needs of equestrians and the community at large. Respect and maintain the vision of previous board members, whose vision is STILL appropriate for the community today.

Dear OC Fairgrounds Board Members,

It is deeply frustrating that the public must once again explain to you all the clear public benefit of the Equestrian Center. Since 2018 and for hours and hours of public comment since, countless individuals have shared firsthand accounts of the positive impact gained at the Equestrian Center and with horses – those that board there, take lessons, have attended public events, participated in free public programs, or simply enjoy having this unique and amazing facility in the community you serve. We ask ourselves; how many more hours of public comment and heartfelt testimonials are required before you will realize the overwhelming public support for this vital resource?

You have received letters from many local governments, public agencies and most recently, Supervisor Katrina Foley. They unanimously support and extol the public benefit the OC Fairgrounds Equestrian Center provides to the community. While you as Board members may hold differing opinions about horses and equestrian centers, it is your duty to listen to and serve the public and to actively listen to the needs and perspectives of the community. The public thinks it is an important public asset. Local governments and politicians think it is. Why is it that OCFEC leadership are the only ones that don't seem to get it?

With privately owned Equestrian Centers being sold to real-estate developers, the responsibility falls on public entities to preserve these vital resources. Your mission statement clearly outlines your commitment to preserve access to agriculture and the Equestrian Center sits at the heart of that mission. There are strong cultural heritage ties to horses within the diverse communities in Orange County – from Black cowboy history to the significance of horses in the Chicano community. Imagine adding in riding programs like the Compton Cowboys or having an Escaramuza Charra group practicing in the arena while the vaulters and Pony Clubbers are working hard on their horsemanship goals. The Equestrian Center has so much unrealized potential to truly serve the public in a variety of impactful ways alongside the benefits it already provides. Why isn't OCFEC leadership interested in helping the Equestrian Center realize its full public potential?

As for Gifts of Public Funds concerns, across the United States, numerous public equestrian centers are built, maintained, and operated with public funds. These centers are not expected to be profit-driven entities, but rather valuable community resources providing benefits beyond financial gain. None of them are violating "Gift of Public Funds" laws. LA County government recently rebuilt and revitalized Whittier Narrows equestrian center that has boarders and trainers and is open to the public. The \$13M investment of taxpayer dollars was made without the expectation of immediate financial return, as the County recognizes the center's value to the community. (please click on link to watch video https://youtu.be/1EsN88_2SeA). Additionally, according to the 2021 OCFEC Equestrian Center conducted by Doug Lofstrom: "It is customary practice at public equestrian centers NOT to charge trainers a fee for their business operation since trainer businesses assists filling stalls for boarding which benefits the public agency".

Regarding “maximum public benefit”, the current metric leadership is using seems to prioritize short-term educational experiences and sheer numbers of visitors. While serving hundreds of thousands of residents annually through site visits is undoubtedly impressive, it fails to capture the deeper impact the Equestrian Center has on many individuals.

Instead of focusing solely on breadth, please consider the depth of impact. The Center currently averages 75,000 public visits annually, and for a significant portion of those visitors, the experience is transformative. In a 2018 public workshop, the Equestrian Center was ranked the most important and impactful public asset on the property. You have all recently heard the parents of neurodivergent children testify to the miraculous changes in their kids' lives thanks to the Equestrian Center's programs. While educating young people about the origins of their food is important, the depth of impact on individuals like these cannot be ignored. Both breadth and depth are crucial for maximizing public benefit, and the Equestrian Center has the space and resources to accommodate both.

Therefore, we urge the Board to continue the RFP process, make room in the budget for the deferred maintenance, capital improvements, and program enhancements and publicly recognize the Equestrian Center as a valuable public asset serving a critical public purpose. Its unique ability to provide transformative experiences for individuals of all backgrounds makes it a vital resource for Orange County.

Think of all the social problems people face today - If you demolish the equestrian center, you will have eliminated a very positive environment for many. We need more places people can go to 'unplug' and reconnect in a healthy environment.

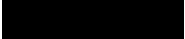

Dear Orange County Fair and Event Center Board Member,

It has come to my attention that this board is advocating for a complete shutdown of the Equestrian Center located on the OC Fair and Event Center. Such a move would, in my opinion, be a huge disservice to the Orange County community and a tragic loss of recreational opportunity to local residents.

It appears that financial loss is one of the points being made for closing the facility. The fairgrounds is a community asset as are parks, including dog parks and other recreational outlets that are valued for the quality of life offered to those that frequent them. They are not expected to “carry their weight” financially. And if they do generate revenue from athletics and other means, it is surely not a requirement for their existence.

I moved to Costa Mesa from a more rural setting in the San Joaquin Valley in 1968. As a child that had access to horses throughout my childhood, the fairgrounds provided a lifeline for me. My family never had the means for me to formally be involved in equestrian activities, but I was able to go to the fairgrounds stables and at least be in the company of horses, which was enough to bridge the gap of the loss I had felt. It’s a misnomer to think that only those participating in riding and training are enriched by the existence of the Equestrian Center.

For many underprivileged or physically challenged children that partake in equine-oriented activities at the fairgrounds, the therapeutic benefits therein cannot be reproduced from any other method, nor the value therein calculated. *It is simply irreplaceable.*

Many other state or county owned fairgrounds across California view the equestrian community as a vital asset. They provide designated land on their grounds for housing horses and promote equestrian activities and events.

Since Costa Mesa and the surrounding cities from which community members come to the Equestrian Center have been essentially built out over any remaining open land, equestrian access and activities for most all

living in proximity to and seeking this recreational outlet falls to this invaluable facility. Given the loss of nearly all other horse stables that were once thriving in the Costa Mesa/Newport Beach/Huntington Beach/Fountain Valley/Santa Ana vicinity, there is no other facility to house the horses currently existing at the fairgrounds. Losing the Equestrian Center would essentially render access to equestrian activities in this immediate region into the history books.

Please do not remove forever an irreplaceable and essential outlet for this community.

Please *find a way* to continue operating the Equestrian Center at the OC Fairgrounds and Events Center.

2. The Board accepts a 700K deficit for Centennial Farms because they have determined that the public outreach and educational activities at the Farm justify the expense.
3. The Board accepts a 300K deficit for Hero's Hall because they have determined that veterans and students touring the museum justify the expense.
4. Over the past decade, the Equestrian Center has NEVER operated at a deficit - until staff took over in 2023 and triggered this public/private debate.
5. I want to play a short video on the recent opening of the Whitter Narrows Equestrian Center on public land in Los Angeles County. Play video or state - what you would have learned if I had been able to play the video is that...
6. Whitter is the largest public equestrian center in Los Angeles County, with 180 stalls. The all-new facilities, office, concessions, and lockers for private owner's tack were built by LA Parks and Recreation and the Department of Public Works with 13 Million in public funds.
7. The paradigm is the same as here: LA Parks does not own the horses, nor do they provide trail rides. They offer boarding and lesson programs under the *private trainers* that are there
8. Supervisor Hilda Solis of the 1st District was a strong supporter, was present at the opening, and was the spokesperson in the video.
9. *Why should you care about an Equestrian Facility in LA County?*
Why should you care about Supervisor Solis?
10. Because they speak to the central question - is spending public funds on an equestrian center a gift of public funds?
11. Supervisor Solis was a CA State Assembly member and then CA State Senator; she served as a CA Representative to Congress and then as Secretary of Labor in the Obama administration before being elected to the LA County Board of Supervisors for the 1st District in 2014.

12. If you are concerned that spending OC Fairgrounds funds on an Equestrian Center is a gift of public funds, you can be assured that Supervisor Solis and other members of the 1st District considered this same question and clearly showed that spending 13 million in public funds ***was not*** an illegal gift.
13. We call on the OC Fair Board of Directors to assert the same - that the Equestrian Center IS serving a public good and that the Equestrian Center is already offering public programs similar to those highlighted in Supervisor Solis's video.
14. We ask that the Board acknowledge that the Equestrian Center does NOT need to turn a profit - even though it ***has*** returned 100K per year in profits in 11 of the last 12 years.

So many house areas have been closing, and owners are forced to move their horses out of our area. We can't afford to own one so having access to places with public riding or even with privately owned barns that can afford to offer lessons because they're boarding fees are not skyrocketing.

Dear OC Fairgrounds Board of Directors,

Thank you so much for taking the time to hear all of the public comment about the Equestrian Center at Thursday's meeting. There definitely seemed to be some confusion, though, about why the public felt the urgent need to attend and submit comment regarding the tremendous public benefits of horses and the Equestrian Center, highlight the importance and impact of the current free, low-cost and for-fee public programming and to voice concerns about the future of the facility.

There was a real disconnect between the Meeting Agenda Item 8B as worded in the posted Agenda:

8B. Discussion Regarding the Development of Public Programming at the Equestrian Center and Vote on Next Steps: Action Item

AND the actual Staff notes posted about Agenda Item 8B on the website which stated the purpose of Item 8B to be:

"During the Board's consideration, it must determine whether or not the equestrian center is currently being used for a public or private purpose. The following questions should be addressed:

1. Is the equestrian center currently serving a public purpose?
2. Is the District receiving adequate consideration for the expense of the equestrian center?

If from the discussion the Board determines the equestrian center is serving a public purpose, it can choose to continue funding the equestrian center operations at a loss or continue the current RFP process to identify a potential independent operator to alleviate the District's financial losses as voted on by the Board at its September 2023 meeting.

If, however, from the discussion the Board determines the equestrian center is serving a private purpose using public funds, it can choose to either continue the current RFP process to identify an independent operator or direct staff to research and recommend how the property (7.5 acres) could be used to serve a public purpose and meet the Board's expectations of "providing public programming to the maximum benefit of the public."

This disconnect between the agenda title and separately-posted meeting notes caused alarm. It was not simply a discussion about developing and adding public programming as titled, but rather a decision that could potentially re-purpose the current 7.5-acre Equestrian Center footprint altogether. The language that "staff will research and recommend how the property (7.5 acres) could be used" does not imply that they will research and recommend how the current Equestrian Center could be used. This is especially of deep concern to the public given that the 7.5-acre Equestrian Center is NOT included in the current Master Site Plan.

The equestrian community, the public, community leaders and facility supporters are especially concerned and “on high alert” given that:

1. The District has doubts about the public purpose and public benefits of the Equestrian Center when its public purpose and benefits seem obvious to all the commenters (and supporters at large), and yet those doubts seem to be driving all important decision-making and legal opinions.
2. Staff did not develop any District-led public programming at the Equestrian Center this year because they were waiting to see if the Board would decide if the facility served a public purpose or not – but if Staff had worked on adding in robust public programming this year and encouraged public engagement, this issue of public purpose would not even be up for question.
3. As tax-paying members of the public who use/visit the public Equestrian Center, just as tax-payers who choose to use municipal, county or state public recreational facilities, there seems to be lingering confusion as to why the people who use the facility are not considered or referred to as members of the public.
4. There is deep uncertainty surrounding the future use of space given that the current EqC is NOT included in the Master Site Plan. Historically, Staff has only ever suggested turning the space into a parking lot/flexible paved space OR relocating the EqC somewhere else and shrinking it from 7.5-acres to one. There have been no other options considered to the best of our knowledge.
5. Just 3 short months ago, the Board was just one vote short of closing the facility for good
6. The RFP for a private operator that would bring up to 20 years of stability and investment to the facility was posted for bid on the same day as an agenda item that would (and did) reverse the board’s prior decision to bring stability and investment to the facility

Given the rapidly disappearing spaces for horses in urban areas, any hint of losing one more boarding stall or one more public lesson program or one more place for the public to interact with horses is cause for great community apprehension.

It is clear that both the Board and the Equestrian Center community (and its supporters at larger) are frustrated and neither side feels understood. For mutual understanding to happen, there needs to be two-way communication between us. We absolutely look forward to working together, in whatever forum you feel is most beneficial, to foster both mutual understanding and the development of an incredible public-serving model not only for the OC Fairgrounds Equestrian Center but for public equestrian centers everywhere.

Dear Chair Kovacevich and Members of the OCFEC Board:

I am writing in strong support of the Orange County Fairgrounds Equestrian Center. The Equestrian Center, which unquestionably serves a public purpose, has firmly established itself as an invaluable asset and resource for a wide range of groups. Just last weekend, the Center hosted a group of foster youth from Olive Crest who enjoyed the opportunity to ride horses, many for the first time.

Under the prior operator, the Equestrian Center had docent-led tours; no-cost horsemanship classes; educational field trips for schools and pre-schools hosted by on-site trainers at no cost to the schools; equine therapy for veterans, at-risk youth, and others; and dozens of other programs and services for the public.

Over the past 20 years, the number of boarding stalls for horses across Orange County has dropped by nearly 80%, from 3,700 stalls countywide to just 784. The equestrian community in Orange County simply cannot afford to lose another 180 stalls if a decision is made to cease operating the Equestrian Center.

Over the past decade, the Orange County Fairgrounds Equestrian Center has generated approximately \$100,000 per year prior to the change in operations last year. I strongly encourage the Board to work collaboratively with the equestrian community to allow the RFP process for a new operator to move forward.

Thank you for your public service and for considering my comments supporting this important public resource on our state property.

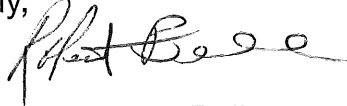
My name is Robert Bell and I have been a part of the Costa Mesa community since 1961.

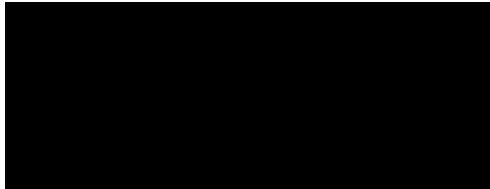
