### **BACKGROUND**

At the January 2025 meeting, the Board of Directors approved the draft 2025-2029 Strategic Plan. The draft plan was posted on the ocfair.com web site along with a portal to collect direct feedback from visitors to the web site. In addition to a home page pop-up connecting web site visitors to the strategic plan and feedback form, an eblast was sent on February 13 to over 7,800 stakeholders inviting them to review the plan and offer feedback.

The deadline for submitting feedback was Thursday, March 13, giving the public a month to review the strategic plan and respond. The District received 505 responses. The responses are categorized as follows:

- Parking – 2 responses
- Centennial Farm/Agriculture – 9 responses
- Strategic Initiatives – 11 responses
- Fair/Concerts – 13 responses
- Miscellaneous – 23 responses
- Equestrian – 447 responses

Copies of all responses submitted by stakeholders and the public are attached for the Board's review and consideration. In addition, staff will present recommendations for any amendments to the strategic plan at the March Board of Directors meeting.

I'm very familiar with the OC Fairgrounds and took a horse back riding class in the 1980s offered at OCCC. As the LAST remaining public equestrian facility, the OC Fairgrounds should be maintained as an equestrian boarding, riding, lesson facility. The Los Angeles Equestrian Center, under the new management of ASM Global, can be a model of excellence to follow. We just also successfully completed the equestrian fire evacuations with hundreds of horses at LAEC. One day, the OC Fairgrounds may need to become that SAFE PLACE for evacuated horses in the OC. Revenue expansion for the OC Fairgrounds can easily be done by creating simple cost effective equestrian programs like: 1. Expanding riding lessons at the OC Fairgrounds from both Orange Coast College and the high school across the street. There is a global intetest for horseback riding. 22 different countries participated in the 2024 Paris Olympics equestrian events. The 2028 Los Angeles Olympics will host the equestrian events close to the OC at Callaway Downs in Temecula. Further, the CA Legislative Analyst reports 11.6 BILLION is contributed annually to the California economy by the equestrian industry. The OC Fairgrounds IS THE PRIMARY STATE OWNED FACILITY to help EXPAND & PROMOTE the business and benefits of CA LIVESTOCK (HORSES) and the AG industries in Orange County. 2. Establishing an equestrian therapy program that supports autism (ORANGE COUNTY #1 in the nation for autistic youth 1:76 kids diagnosed); veterans with PTSD, and first responders, many who are suffering from mental health issues from the recent devastating January 2025 fires; 3. Establish year round pony camp, Horsemans 101 classes for youth. Especially the low income youth from surrounding cities: Stanton, Santa Ana and Tustin areas. This could be an intro class with basics. Also, the Girl Scouts of Orange County and Boys Scouts of Orange County can do their horsemanship badges at the OC Fairgrounds; 4. Establish a small rental string and do 1 hour trail rides. There are so many established open recreational trails surrounding the OC Fairgrounds. These are already identified on the OC County Parks maps. Linking these trails creates a permanent open recreational space for equestrians, hikers, and bicyclist to enjoy. It also bring added value to the State owned property as THE equestrian anchor for all statewide equestrians to visit the state owned OC Fairgrounds facility. It is easy to put up RV designated parking areas with horse trailers and pipe corral for a weekend getaway. This is can be similar to the various state parks that already provide over night horse camping and the CA Coastal Commission's 30 mile equestrian trail with the public access point in the Del Monte Forest next to Pebble Beach golf course. 5. Add a small petting zoo with dwarf goats, sheep, pigs, mini horses, mini donkeys, a pony ride for toddler-preschool ( ages1-5) with a chicken coop, geese and ducks to introduce small children the love of farm animals. In conclusion, horses are part of California's history long before California became a state in 1870. It is a lifestyle embedded deep in the California Rancho system and is part of the folklore of the American West. If we as a society do not preserve and respect the equestrian lifestyle in 2025, when our kids and grand kids grow up, there will be no more horses to love and care for in 2040 and our historic lifestyle will be lost forever. Share the OC Fairgrounds with equestrians. Create an Advisory committee with knowledgeable equestrians to help the OC Fairground Board of Directors and staff (who are not equestrians or industry knowledgeable of best practices).Do a new plan in a efficient, cost effective manner that has built in risk management models for success and a diversity of programs to ensure success and new revenue streams. There used to be two buildings with vendors, parking and entrance cost is way too expensive, food cost is totally out of control, rides are too expensive. Fairs are no longer family friendly financially! When I first started LA County Fair, they had 8-9 buildings of vendors, this year they will probably be down to two!!! Booth are WAY TOO EXPENSIVE: \$4,500.00 to \$5,000.00 for a 10x10 inline booth for 16 days! There for a month but down 3 days a week. So three days of no income! You might see the person in charge of vendors once! I stopped all fairs but close to home, LA, SD and OC. AZ State Fair went to 6 weeks! No one was there for the first two weeks because it was 114 degrees and they turned off the air! It took 4 weeks just to pay for booth! Never again. They don't give a damn!!! Last year at the Riverside County Fair, I got lied to and one of the employees copped an attitude twice. Opening day, no power, raised fees, down one aisle of vendors, It was the worst year in 25 years! Many vendors didn't make enough money to pay for their booth!!! The money people no longer go to the fair. This year they extended the dates of the fair and it now conflicts with Imperial Fair. HELLO!!!</p> <p>Fairs are down thousands of fairgoers because of restrictions and pricing. Smaller business' can no longer afford a booth so they are gone. When we have to pay \$4,500.00 for a booth, 2 -3 thousand for hotel expense, insurance, travel, food, how can so many be able to afford being vendors? I know this all doesn't have to do with OC Fair but this has been my and every other vendor's feelings. So many fairs have turned into pure greed and most don't give a damn about the vendors. Over the past 25 years the attitude of vendors with many fairs is that once they have our money, we can go blank ourselves! One of the reasons that the Fair Industry is dying!!! At the closing of the OC Fair, a few of us pack up and want to leave that night, but we have to wait until entrances have been taken down, sometimes waiting until 2AM before we can enter lot. Please open up the north entrance where the Sheriff's station is so when they clear the fairgrounds we can get in that night. Accolades to Brenda Keasberry. We do see her several times a day, checking on the vendors making sure everything is ok. If there is a problem she is right there to help, and appreciates when we give her a heads up about a problem child. Many other fairs you never see the people from the front office, if you do, they rarely engage or just walk by looking at the floor, no contact. This past year I became an "Approved Vendor" for L.A.P.D. Except for the 3 summer fairs in Southern Ca, my business is working in law enforcement agencies. LA Fair down numerous buildings, OC down one, my building at SD is down 1/4 of vendors, AZ State Fair, down probably 60-70%. They used to have 400 vendors in the building, with only 3 cross aisles where the doors are and I would do about 150 sales. Past several years, just about every 2-3 booths is a cross aisle. They advertise as the improved traffic flow because so many booths are now corner booths!!! Do they think we are stupid?!?! They don't get it and don't care. I turned it over to my distributor this past year and in 6 weeks, he only did 27 sales!!! (no money crowd). They need to start thinking business since fairs are a business and not with a government mentality! We are the ones on the "Front Lines". Thank you for allowing more fairgoers into the fair but still has LTD entrance. Many of the seniors come early in the morning and are gone by 2 or 3. We may lose several thousand potential prospects for sales but how do you refill the people who left early because of LTD fairgoers amount has been met for the day? I hope that the information given here can help for a better experience for the vendors and fair goers. All the best for a prosperous 2025!!!</p>


